Packages:

Straight: \$300.00- 1 camera is used to film the Ceremony. At the end of the event, you will receive one mini-DV tape containing all the footage captured during your event. You can return that to us, edit it yourself, or give it to any editor whenever you wish to have it edited. HD add \$100.00

\$400.00- 2 cameras will be used to film the Ceremony. At the end of the event, you will receive two mini-DV tapes containing all the footage captured during your event. HD add \$200.00

\$500.00- 3 cameras will be used to film the Ceremony. At the end of the event, you will receive three mini-DV tapes containing all the footage captured during your event. HD add \$300.00

With any straight package you have the option of having j razz creations edit the footage for the remainder of the package fee for up to one year after filming the event. For example, you purchase the one camera straight package; for up to one year after the event j razz creations will edit that footage for you while subtracting the initial fee (cost of the straight 1 camera cost) from the total of the Basic 1 camera package.

Basic: \$750.00- 1 camera is used to capture the Ceremony. The editing of the video will only be limited by the footage captured and this will be placed on a DVD without a menu but with scene selections. Royalty free music is added as needed. A wireless lapel mic may be utilized if needed. No case or printed DVD is included. (A menu is \$50.00 more).

Basic HD: \$950.00. 1 High Definition video camera will be used to film your wedding. The editing of the video will only be limited by the footage captured and this will be placed back to miniDV tape while maintaining the high definition quality. (Currently, at the time of writing this contract, there are no economical ways to distribute HD video like DVD or VHS, although Blu-Ray Discs and HD DVD discs are coming soon. Once this technology is more accessible it can be transferred to one of the above named formats for \$50.00. Same terms apply as listed above under Basic.

Midrange: \$1050.00- **2** cameras are used to capture the Ceremony & 1 for the Reception. Editing is included along with scene selections. Royalty free music is added where needed. A wireless lapel mic may be utilized if needed. Comes with a DVD paper sleeve, and a printed DVD. (A menu is \$50.00 more).

Midrange HD: \$1250.00. **2** High Definition video cameras will be used to film you wedding & 1 for the reception. Same terms apply as listed above under Midrange.

Premium: \$1550.00- **3** cameras are used to capture the Ceremony, 1 for the Reception, and 1 for the Pre-ceremony interviews. Up to two wireless lapel mics will be utilized if necessary for capturing sound along with up to two shotgun mics. Full editing is included along with scene selections and a fully functional DVD menu. Royalty free music will be added free of charge if needed. This package also comes with a case, a case print, and a printed DVD.

Premium HD: \$1750.00. **3** High Definition cameras are used to capture the Ceremony, 1 for the Reception, and 1 for the Pre-ceremony interviews. Up to two wireless lapel mics will be utilized if necessary for capturing sound along with up to two shotgun mics. Same terms apply as listed above under Premium.

Premium Plus: \$650.00+ (*Only available for the Premium package*) This includes a video shoot prior to the wedding (Days or Weeks in advance) to obtain video segments to incorporate into the wedding DVD as well as voice-overs that can be added to the final DVD. It is ideal to secure a day at the wedding venue to do this when you both have access to your wedding day apparel.

I. OVERVIEW

I can film your wedding using 1, 2, or 3 digital High Definition or Standard Definition video cameras (placed at your discretion) usually one is distant and two are close up (the audio used in editing will be from the close-up camera/s and/or lapel mic).

The quality of the film will only be what you allow it to be; i.e. the more freedom you give me to be in conspicuous places the better the video, but the less freedom you give me the better the true life experience will be.

Hint: There will have to be a compromise if you want your money's worth.

II. CONCEPTS AND METHODOLOGY

Here are the steps normally involved in having a video made successfully for you:

- I must attend the rehearsal
- I must be able to have an accurate portrayal of the lighting situation
- I must be able to have an accurate portrayal of the sound situation
- I must be able to be in places that will allow me to have good shots
- I will need some extra time with you, the couple, the wedding party and the pastor to go over certain scenarios so that I will be sure to get important shots
- I will need to know where décor will be placed and people will be standing (plant placement, candle placement etc.)

(These aspects are most important as they will determine the quality of the product you receive!)

III. DVD AUTHORIZING

I will provide for you one DVD that has been edited complete with a menu screen and scene selections if this is the package you have paid for. If you want music added to the DVD I can provide it at my discretion, free of copyrights, or you can provide me with a burned CD containing the songs you would like for me to incorporate in the editing process but you will be responsible for obtaining copyright permissions and supplying me with the proper documentation.

COST

The set cost is determined by the package(s) that you pick above. This does not include travel or sleeping arrangements if travel is required. If you purchase any of the premium packages, you will secure j razz creations to videotape the wedding ceremony along with the reception, pre-ceremony interviews, and to compile and edit the compilation into a DVD. In return you receive the finished DVD, case, insert, and DVD print. Any additional service or element of a package you purchase will be added to the set cost of the package you choose and the price will be adjusted accordingly.

Travel will be set at 46 cents a mile based on Google Maps if myself and my partner will not be flying. I will need for you to set up sleeping arrangements for myself and one assistant. (Travel is only charged for events outside of the Jackson TN area).

IV. PHOTO MONTAGE

j razz creations can fashion a photo montage that is set in a motion-filled environment, complete with royalty free music and your very own pictures! This presentation can be placed on DVD, or a Windows Media File which can be played on computers and some DVD players. If you would like to see a sample, feel free to browse my website. It is very effective to show to guests at the wedding while they are waiting for the Ceremony to begin, or in between the Ceremony and the Reception, which will allow time for the bride and groom to spend some time together or will allow time for you to eat before everybody else comes into the reception area. It is also a good keepsake and a creative way to enjoy your wedding pictures for years to come!

The set cost for this option is 2 dollars a picture in digital format (on a cd) or 4 dollars if j razz creations has to scan in the pictures. Contact us using the "Questions?" link on my website.

j razz creations will not be held liable for faulty tapes or equipment malfunctions. This is a live event where there are no "take 2's". j razz creations will do everything possible to ensure there are no technical problems in preparation for the wedding day.

j razz creations reserves the right to use the footage captured as well as the finished product for advertising or other purposes; j razz creations also retains the rights to the footage and finished product unless a written agreement has been worked out prior to the wedding day where rights are handed over or shared with the purchaser of the rights.

If you have any questions pertaining to this contract, please ask them before the day of the wedding. A deposit amounting to half of the total is required to hold the date and if you make a cancellation you forfeit your deposit.
